COURSE: HS-06 SOCIAL AND ECONOMIC ASPECTS OF PUBLIC HEALTH

CREDITS: 3 American (recommended), 5 ECTS

LANGUAGE OF INSTRUCTION: English

DESCRIPTION: This course provides a topical overview of the inter-disciplinary field of Public Health and grounding in the public health paradigm. Through a series of lectures, students learn about the core public health sciences including social sciences, biostatistics, economy, epidemiology, environmental health and policy and management. Other topics include spiraling health care expenditures, ethics in public health, new therapies in medicine, community participation in research, public health promotion, and the public health challenges in the 21st century.

OBJETIVES:

Upon completion of the course, students have a general background of significant social, economic, cultural, and behavioral issues related to public health. The students will be able to:

- Describe Public Health's essential missions, goals, services and core functions.
- Understand the economic challenges that govern public health systems.
- Identify ethical principles that guide public health practice.
- Identify social dimensions of public health such as urban health, culture and ethnicities, academic-community partnerships, and community assets and resources.

CLASS FORMAT:

Teaching methods in this course include lectures, case studies, teamwork and class discussion and debate. Videos, documentaries and other visual materials are used as supporting means of teaching during the length of this course. Visits to different medical/health centers will take place during the course.

TOPICS:

- Unit 1: Introduction to Public Health Paradigm: social determinants and economic inequalities of health.
- Unit 2: Principles of epidemiology in Public Health: measures of disease frequency, comparing disease, etc.
- Unit 3: Public Health and its relationship with economic and social aspects of globalization:
- Unit 4: Public Health challenges: pandemic flu, HIV/AIDS, obesity, tobacco use, environmental degradation.
- Unit 5: Interventions to promote equality and reduce health disparities. Can they be economically sustainable?
- Unit 6: Health Behavior: Prevention and interactions between Public Health and Society.
- Unit 7: Ethics in Public Health: community participation in research, information patterns,...
- Unit 8: New therapies in Medicine (gene and cell therapies,...) and its cost to Public Health System.
- Unit 9: Spanish model of Public Health: relation cost-benefits.
- Unit 10: Spanish model of Transplantation and the role of the ONT organization.

- Unit 11: Social and economical comparison between different Public Health systems over the world.
- · Unit 12: Role of the World Health Organization (WHO) in PH
- Unit 13: Increasing costs in Public Health: what must be done to protect the system?
- Unit 14: Role of families and spirituality in Public Health and/or medical care.
- Unit 15: New challenges for Public Health in the 21st century: how suitable are existing institutions?
